### Grand Parkway (SH 99) Segments F & G

- Limits: From US 290 to I-69N/US 59N
- Current Status: Implementation

#### SH 288 Toll Lanes in Harris County

- Limits: From US 59 to Harris/Brazoria County Line
- Current Status: Implementation

#### Grand Parkway (SH 99) Segments H & I

- Limits: From North I-69N/US 59N to SH 146
- Current Status: Active Procurement

#### SH 249 Extension Project

- Limits: From FM 1774 in Pinehurst to SH 105 in Navasota
- Current Status: Active Procurement

## Grand Parkway Segments F-1, F-2 & G: Project Overview

- CDA Design-Build with CMA Delivery Model
- 38 mile new location four lanes toll road (2 lanes in each direction) with discontinuous frontage roads
- From US 290 to I-69N/US 59N
- Interchanges at US 290, I-45, and I-69N/US 59N
- In Harris and Montgomery Counties




## Grand Parkway Segments F-1, F-2 & G: Project Overview

- Design-Build Contract Executed on March 22,2013
- ROW acquisition: 433 Total Parcels, 100%
  released for construction
- Construction began in June 2013
- Substantial completion
  - F-1: achieved on February 2, 2016
  - F-2: achieved on February 5, 2016
  - G: achieved on March 29th 2016





### SH 288 TxDOT Project Overview




#### **TxDOT Project:**

- Limits: SH 288 Toll Lanes in Harris County, 10.3 miles from U.S. 59 to the Harris/Brazoria County Line
- Project scope includes:
  - A toll **concession**, under a CDA for a 52 year term
  - 4 tolled lanes (2 each direction) within existing SH 288 median
  - Innovative ATC: Reconstruction of all 8 direct connectors at IH 610 with added access to toll lanes
  - Addition of 8 new tolled direct connectors at Beltway 8
  - 2 tolled direct connectors to Holcombe Boulevard near the Texas Medical Center (inbound and outbound)
  - Developer to operate and maintain facility from ROW to ROW

### SH 288 TxDOT Project Overview

- Capital costs: \$800 million
- Funding:
  - Public Funds by TxDOT
  - Developer equity
  - Developer secured TIFIA loan
  - Developer secured Private Activity Bonds
- Disadvantage Business Enterprise Participation goal is 12%
- Project must accommodate the ultimate configuration which includes:
  - Improvements to IH 610 from west of Cambridge to Scott Street
  - One additional General Purpose Lane on SH 288 in each direction from IH 610 to Beltway 8
- February 26, 2015 Conditional Award to Blueridge Transportation Group (the "Developer") by Texas Transportation Commission

## SH 288 Brazoria County Project Overview




#### Brazoria County Toll Road Authority (BCTRA) Project:

- 5 miles from Harris/Brazoria County line to CR 58/Croix Rd
- Project Scope:
  - 4 tolled lanes (2 each direction) within existing SH 288 Median
  - Hughes Ranch Road T-ramp access to and from toll lanes
  - Braided entrance and exits to SH 288 frontage road North of FM 518
  - Slip ramps between general purpose lanes and toll lanes south of FM 518 and CR 58/Croix Rd
- Toll lane operation and maintenance by BCTRA
- Design-Bid-Build Delivery
- Start of construction is expected 6 months after start of construction of TxDOT Project
- End of construction is expected at the same time or after end construction of TxDOT Project

### Grand Parkway (SH 99) Segments H & I: Project Overview

- Segments H, I-1 & I-2
  - Segments H and I-1
    - Proposed Two to Four Toll Lanes, 37.5 miles, I-69N/US 59N to I-10E
    - Interchanges at I-69/US 59, US 90, and I-10E
  - Segment I-2
    - Existing (I-2A): Four Toll Lanes, 8.7 miles, I-10E to FM 1405
    - Proposed Toll Lanes (I-2B): Four Toll Lanes, 6.5 miles, FM 1405 to SH 146
  - TxDOT Districts Beaumont and Houston
  - Harris, Montgomery, Liberty and Chambers Counties
  - Subject to Market Valuation Waiver Agreement executed by the State and seven counties for Grand Parkway Implementation
  - SB 1420 Committee formed September 2013
  - Revised project constraints to allow Design/Build/Maintain
  - Grand Parkway Transportation Corporation formed March 29, 2012





- Project Length: 24 miles
- Segment 1 in Montgomery County
  - ROD Approved in January 2016
  - Base Scope: Super 2 from FM 1774 in Pinehurst to FM 1774 in Todd Mission
  - Options for 4 lanes (2 lanes in each direction)
- Segment 2 in Grimes County
  - Environmental clearance anticipated Q3 of CY16
  - Base Scope: Super 2 from FM 1774 in Todd Mission to SH 105 in Navasota
  - Option for continuous 56-ft cross-section in lieu of periodic passing lanes under Super 2 configuration


